The following page will serve as your Official Notification of the Election of Officers and Directors, delivered to you as required by Article V of the SEAMS Bylaws.

Article V -- Election of Officers & Directors

The president shall select a nominating committee of himself and not less than two (2) past presidents to prepare a slate of candidates for officers and directors for the coming year. This report must be submitted in writing to the Membership not less than two (2) weeks before the annual meeting of the Association. Members-at-large may submit nominations in writing to the secretary not less than one (1) week before the annual meeting. The election of officers and directors shall be held at the annual meeting on a date in the fall of each year, which the board of directors shall select. New officers and directors shall take office on the first day of the new Fiscal Year, as determined by the executive committee. Any person serving as a director or an officer, whose employment status changes, such that they are no longer employed in the sewn products industry or by a SEAMS member in good standing, may continue to serve in their elected position until the end of the SEAMS fiscal year in which the change occurs.
